

### By-Law Title: Census

Being a by-law of the Hamlet of Clyde River in the Northwest Territories to provide for Census to be taken, pursuant to the provisions of the *Hamlets Act*.

WHEREAS the Hamlet of Clyde River desires to conduct a census within the Municipality;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CLYDE RIVER, at a duly assembled meeting enacts as follows:

#### SHORT TITLE

1. This by-law may be cited as the "Census By-Law".

#### **INTERPRETATION**

2. In this by-law:

a)	"Census"	means the official recording of the number of residents in the Municipality and the gathering of other information as set out in 'Schedule A';				
b)	"Council"	means the Council of the Hamlet;				
c)	"Hamlet"	means the Hamlet of Clyde River in the Northwest Territories;				
d)	"Municipality"	means the geographic area of jurisdiction of the Hamlet;				
e)	"Public Notice"	means the giving of a notice to the general public in accordance with section 212 of the <i>Hamlets Act</i> ;				
f)	"Schedule"	means a schedule attached to and forming part of this by- law;				
g)	"Senior Administrative Officer"	means the Senior Administrative Officer of the Hamlet.				

#### CENSUS

- 3. a) A census shall be taken in the Municipality between 9:00am on Monday the \_\_\_\_ day of \_\_\_\_\_, 1989 and 5:00pm on Friday the \_\_\_\_ day of \_\_\_\_\_, 1989.
  - b) The Senior Administrative Officer shall give public notice at least ten (10) days before the day the census will be taken in the Municipality.
  - c) Every person who is employed by the Hamlet to conduct the census shall carry proper identification and shall produce it upon the request of any resident of the Municipality.
