A by-law of the Municipal Corporation of the Hamlet of Clyde River in the Northwest Territories to acquire Real Property, pursuant to the provisions of the *Hamlets Act*.

WHEREAS the Council of the Hamlet of Clyde River deems it to be in the public interest to acquire the lands described hereunder;
